NOTE: Data are for cases filed on or after October 17, 2006, and closed during the reporting period. Nonbusiness debt includes consumer debt, as defined in Section 101 of the U.S. Bankruptcy code, and other debt that the debtor indicates is not consumer debt or business debt. The United States territorial courts assume the jurisdiction of United States bankruptcy courts within their respective territories, which do not have separate bankruptcy courts.

[1] Total cases closed includes all chapter 13 individual debtor cases with predominantly nonbusiness debt closed during the reporting period regardless of whether such cases were closed due to plan completion or dismissal.

[2] Modifications may be made to a plan after initial plan confirmation. Such modifications typically involve significant changes in the terms of the plan.

[3] Cases refiled after dismissal are defined as those chapter 13 cases filed during the reporting period where at least one of the debtors was also a debtor in a chapter 13 case dismissed within six months of the filing date of the current case.

[4] The United States Bankruptcy Court for Arkansas (AR) includes both the Eastern and Western Districts of Arkansas.
